Dear Prof. Urquidi,

with separate mail I have sent you a copy of a special issue on "Industrial Redeployment and International Transfer of Technology: Trends and Policy Issues" of Vierteljahresberichte. Probleme der Entwicklungsländer (Friedrich Ebert Foundation, Bonn/FRG), March 1981.

This special issue deals with international transfer of technology and its role for the industrialization of the Third World. Its focus is on identifying some of the complex and contradictory interrelations prevailing between the restructuring of world industry, both geographic and sectorial, and the dominant pattern of innovation, transfer of and control over technology. Particularly it discusses the impact of recent technological break-throughs in the OECD region, and shows that most of the prevailing expectations of how restructuring of industries in the industrialized countries and redeployment of industries to the Third World would interrelate, will have to be considerably revised.

I would be glad to hear from you again, and particularly to receive critical comments. I would also very much appreciate to learn more about present activities of the Centro Tepoztlan.

Subject: U.S.A.: Past, Present, and Future

We received your notes on the June 2 meeting held in New York and the materials on the Aspen Institute we had requested, and are very grateful for them. Our records on the agreements reached that day, coincide with yours. Only a few points of clarification: it was Vicente Sánchez (General Coordinator of the Centro Tepoztlán and Research Fellow at El Colegio de México) and not Eduardo Terrazas who accompanied me and was present at the meeting; also we believe to have agreed that although no journalist would be invited to participate in the meeting, we would prepare a press release and arrange for a television interview with a few selected participants, after the end of the meeting.

The relevant background materials on the United States, published in Mexico or Latin America are being selected and we hope to be able to send them to you before August 1.

Reservations have been made in the Hotel Hacienda Cocoyoc to accommodate up to 30 people, and also for the use of the conference facilities from February 21 to 27.

Attached you will find a proposed agenda which has been prepared on the basis of the subjects recommended by you and those in our earlier proposal. Also attached, a list with people we propose to invite.
